

Privacy Policy

Dolce Design Group, LLC will always keep all client information confidential and may only share it with the Network of Partners with the client writing consent and approval. Client information will not be disclosed in any way, shape or form to third parties unless client approval in writing.

When you contact Dolce Design Group, LLC, we may collect any information that you provide us over the phone or in any other way in order to contact you about our products and services. Additionally, if you want to learn more about our services, we may request that you fill out a form in which we ask for information such as your first/last name, mailing address, email address, as well as your phone number.
